Chemical requirements were modified in the way of excluding from the Technical Regulation of the classification of substances and mixtures carcinogenic, mutagenic and toxic for reproduction function for the reason that medical criteria for the safety of toys for children's health and the requirements for toys are contained in the State sanitary rules and norms of safety of toys and games for children's health of 30 December 1998 No. 12 (DSanPiN 5.5. 6.012-98), approved by the Chief State Sanitary Doctor of Ukraine.  The mentioned draft Resolution of the Cabinet of Ministers of Ukraine (attached, in Ukrainian) contains also provisions as to: - Technical Regulation on the Safety of Toys implementation Plan; - amendments to the list of public market surveillance bodies, approved by the Cabinet of Ministers of Ukraine of 01 June 2011 No. 573; - repealing of the Resolution of the Cabinet of Ministers of Ukraine of 8 October 2008 No. 901, which approved the current version of the Technical Regulation on the Safety of Toys.
