REGULATION OF THE MINISTER OF INDUSTRY

NUMBER: 92/M-IND/PER/11/2007

ON

THE OBLIGATORY ENFORCEMENT OF INDONESIAN NATIONAL STANDARD (SNI) ON 5 (FIVE) INDUSTRIAL PRODUCTS

Considering: **a.** that in order to support the transfer of energy from kerosene to gas, to assure the quality of industrial output and to achieve efficiency of production, to protect the consumer in terms of product quality, and to create fair commercial competition, the mandatory SNI shall be enforced on 5 (five) industrial products;

b. that based on the consideration stipulated in **a**, a Regulation of the Minister of Industry shall be issued.

DECIDES

To stipulate: MINISTER OF INDUSTRY REGULATION CONCERNING THE OBLIGATORY ENFORCEMENT OF INDONESIAN NATIONAL STANDARD (SNI) ON 5 (FIVE) INDUSTRIAL PRODUCTS

Article 1

(1) The obligatory enforcement of Indonesian National Standard (SNI) or its revision on the 5 (five) industrial products are as follows:

1.	LPG steel tube	SNI 1452:2007	HS 7311.00.91.00 HS 7311.00.99.00
2.	LPG Steel tube valve	SNI 1591:2007	HS 8481.80.21.00
3.	Single-furnace, LPG gas stove with Mechanical Ignition System	SNI 7368:2007	HS 7321.11.00.00 HS 7321.81.00.00 HS 7321.90.90.00
4.	Low-pressure regulator for LPG steel tube	SNI 7369:2007	HS 8481.10.90.00 HS 8481.80.30.00
5.	Gas-stove rubber hose	SNI 06-7213-2006	HS 4009.11.00.00 HS 4009.12.00.00

(2) Before assembly, the LPG steel tube and its valve are stated as two separate products in accordance with the provision of Article 1, paragraph 1.

Article 2

The Company that manufactures the product as described in Article 1, paragraph 1, is obliged to:

- a. implement SNI and have SNI Product Certification (SPPT) in accordance with applicable regulations; and
- b. apply the SNI mark to each product in accordance with applicable regulations

Article 3

Each product as described in Article 1, paragraph 1, which is manufactured for trade within the country, produced either domestically or imported, is obliged to fulfil the SNI requirements as described in Article 2.

Article 4

Issuing of the SPPT-SNI certification as described in Article 2 shall be performed by an Institution for Product Certification (LSPro) that is accredited by the National Accreditation Committee (KAN) or authorised by the Minister of Industry.

Article 5

- (1) During the course of the first year following the enforcement of this Ministerial Regulation, the issuance of SPPT-SNI as described in Article 4 shall be performed based on:
 - a. National Standardisation Guidance PSN 302-2006: Suitability Assessment Fundamental Product Certification, System 5, namely:
 - 1. testing product quality suitability with SNI;
 - 2. auditing the implementation of the quality management system SNI 19-9001-2001/ISO 9001:2000 or its revision or any other recognised quality management system; or
 - b. National Standardisation Guidance PSN 302-2006: Suitability Assessment Fundamental Product Certification, System 1b, namely:
 - 1. testing each batch of products for quality suitability with SNI;
 - 2. in-factory verification of production facilities and quality control in accordance with SNI.
- (2) Upon the first year of enforcement of this Ministerial Regulation, the issuance of SPPT-SNI as described in Article 4 shall be performed by:
 - a. testing of product quality suitability with SNI; and
 - b. auditing the implementation of quality management system SNI 19-9001-2001/ISO 9001:2000 or its revision or any other recognised quality management system.

Article 6

The Institution for Product Certification as described in Article 4 shall report its certification result to the Director General of Metal, Machinery, Textile and Multifarious Industries or to the Director General of Agricultural and Chemical Industries in accordance with the scope of its authority, and shall send a copy to the Head of Industrial Research and Development of the Department of Industry.

Article 7

- (1) Products imported into Indonesian Customs are obliged to meet SNI requirements, which is proven with SPPT-SNI certification.
- (2) Imported products bearing SPPT-SNI certification must be registered in accordance with the provisions of applicable laws and regulations.

Article 8

Products for import that fail to meet the requirements described in Article 3 are prohibited from entering Indonesian Customs and must be re-exported or destroyed.

Article 9

- (1) LPG steel tubes that have been in production and distributed for a maximum of 10 (ten) years before the enforcement of this Ministerial Regulation must be re-tested by the LPG Steel Tube Management in accordance with SNI requirements as described in Article 1, paragraph 1, point 1.
- (2) LPG steel tubes that have passed re-testing as described in paragraph 1 above shall be subject to annual re-testing.

Article 10

- (1) The development and supervision of the implementation of SNI requirements on products as described in Article 1, paragraph 1, and supervision of the implementation of the provision of Article 9 shall be performed by the Director General of Metal, Machinery, Textile and Multifarious Industries or Director General of Agricultural and Chemical Industries in accordance with the scope of authority.
- (2) The Director General of Metal, Machinery, Textile and Multifarious Industries and the Director General of Agricultural and Chemical Industries shall stipulate the technical guidelines for the implementation of this Ministerial Regulation.
- (3) The Industrial Research and Development Agency shall perform the development of suitability at the Assessment Institute in light of the obligatory implementation of SNI on products as described in Article 1, paragraph 1.

Article 11

Violators of any of the provisions contained in this Minister Regulation shall be subject to such penalties permitted by the prevailing laws and regulations.

Article 12

With the stipulation of this Ministerial Regulation, the Regulation of the Minister of Industry Number 04/M-IND/Per/1/2007 regarding the Stipulation of 6 (six) Technical Specifications for Industrial Products is hereby revoked and declared void.

Article 13

This Ministerial Regulation shall come into force on the date of its stipulation.

For the purpose of public recognition hereof, it is hereby instructed that this Ministerial Regulation is promulgated in the State Gazette of the Republic of Indonesia.
