- Considering:
- a. That in order to assure quality and production efficiency, to protect the consumer in respect of product quality, and to create fair trade practices, an obligatory valid Indonesian National Standard (SNI) must be applied to sheet glass;
 - b. That pursuant to the above consideration, it is necessary to issue a Minister of Industry Decree.

- Having regard to:

DECIDES:

To Stipulate: DECREE OF THE MINISTER OF INDUSTRY ON THE OBLIGATORY VALIDITY OF AN INDONESIAN NATIONAL STANDARD (SNI) FOR SHEET GLASS.

Article 1

Under this Ministerial Decree, the following definitions shall apply:

- a. Product Certification for the application of Indonesian National Standard (hereinafter referred to as SPPT-SNI) is to be issued by the Product Certification Institution to producers qualified to produce goods and/or services according to SNI requirements.
- b. The National Accreditation Committee (hereinafter referred to as KAN), is an institution with the authority to accredit institutions and

laboratories to conduct certification activities.

- c. The Product Certification Institution (hereinafter referred to as LSPro) is a KAN-accredited institution that is permitted to conduct product certification for SNI labels.
- d. The Director-General of Industrial Supervision is the Director-General of Agro Industry and Chemicals of the Department of Industry.
- e. The Head of BPPI is the Head of Industrial Research and Development of the Department of Industry.
- f. The Head of the Provincial Office is the Head of the Provincial Office responsible for implementing all administrative affairs in the industry sector.
- g. The Head of the Municipal/City Office is the Head of the Municipal/City Office responsible for implementing all administrative affairs in the industry sector.

Article 2

- (1) To put into effect the obligatory validation of SNI on Sheet Glass of SNI 15-0047-2005, covering:

- (2) If the SNI for sheet glass referred to in paragraph (1) is revised, the previous SNI for sheet glass would prevail.

Article 3

Companies producing Sheet Glass as referred to in Article 2 should apply for SNI by:

- a. applying for and obtaining SPPT-SNI for Sheet Glass according to the regulations in force; and
- b. putting SNI logos onto each sheet glass product according to the regulations in force.

Article 4

Any sheet glass as explained in Article 2 to be marketed within the country, either domestically produced or imported, must meet SNI requirements as stipulated in Article 3.

Article 5

- (1) The issuing of SPPT-SNI for Sheet Glass, as mentioned in Article 3(a), shall be performed by LSPro with KAN accreditation and the appropriate authority or as appointed by the Minister of Industry, through:
 - a. quality adherence testing of sheet glass according to SNI 15-0047-2005 or its revisions; and
 - b. quality management system audit of SNI 19-90012001 and ISO 9001-2000 and its revisions, or other accredited quality management system.
- (2) The tests, as stipulated in paragraph 1(a), can be subcontracted to a KAN-accredited testing laboratory with appropriate authority or an overseas testing laboratory, provided that a Mutual Recognition Arrangement (MRA) between KAN and the Accreditation Institution of that country, and bilateral or multilateral agreements on technical regulations have been established with the Republic of Indonesia.

- (3) A quality management system audit, as mentioned in paragraph 1(b), shall be based on the assurance issued by Quality System Certification Institution that has been accredited by KAN or an overseas accreditation institution having a Mutual Recognition Arrangement (MRA) with KAN.

Article 6

- (1) As mentioned in Article 5, LSPro shall report its certification process to the Director General of Industrial Supervision by carbon copying it to the Head of BPPI.
- (2) The LSPro issuing SPPT-SNI for sheet glass shall be responsible for monitoring and supervising the use of any SNI logo for any SPPT-SNI that has been issued.

Article 7

- (1) Any sheet glass mentioned in Article 2 that has been imported to the Indonesian customs territory must comply with SNI requirements as specified in Article 3.
- (2) Imported sheet glass that has already obtained SPPT-SNI must be registered according to rules and regulations in force.

Article 8

- (1) Any sheet glass which has been produced locally and which fails to meet SNI requirements should not be distributed and must be destroyed.
- (2) Imported sheet glass which fails to meet SNI requirements as mentioned in Article 7 are not permitted to enter the Indonesian customs territory and must be destroyed or re-exported.

Article 9

- (1) The monitoring and supervision of SNI implementation on sheet glass as mentioned in Article 2 shall be conducted by the Director-General of Industrial Supervision and operated by a Quality Standard Officer of Goods or Services (PPSP) at least once (1 time) per year.
- (2) During the supervision process as mentioned in paragraph 1, the Directorate-General of Industrial Supervision may work with the Head of the Provincial Office and or the Head of the Municipal/City Office or related institutions.
- (3) BPPI will monitor the Compliance Monitoring Institution in its duty to ensure the obligatory implementation of SNI for sheet glass.

Article 10

The Director-General of Industrial Supervision will issue technical guidelines to accompany this Ministerial Decree.

Article 11

Any violation of the provisions of this Ministerial Decree by business entities will result in sanctions according to the rules and regulations in force.

Article 12

This Ministerial Decree shall come into effect 6 (six) months after the date of its stipulation.

In order to make the public aware of this Ministerial Decree, it is required that this decree be announced in the State Gazette of the Republic of Indonesia.
