THE CROPS ACT, 2013

(No 16 of 2013)

IN EXERCISE of the powers conferred by section 40 of the Crops Act, 2013 the Cabinet Secretary for for Agriculture, Livestock and Fisheries makes the following Regulations—

THE CROPS (NUTS AND OIL CROPS) REGULATIONS, 2016

PART I—PRELIMINARY

Citation and commencement.	1. These Regulations may be cited as the Crop (Nuts and Oil Crops) Regulations, 2016 and shall come into force on such date as the Cabinet Secretary may, by notice in the <i>Gazette</i> , appoint.
Interpretation.	2. In these Regulations unless the context otherwise requires—
	"agent" means a person appointed in writing by the Authority to carry out specific duties and functions in the nuts and oil Crops subsector on behalf of the Authority
No. 13 of 2013.	"Authority" means the Agriculture and Food Authority established by section 3 of the Agriculture and Food Authority Act, 2013;
	"Cabinet Secretary" means the Cabinet Secretary for the time being responsible for matters relating to agriculture,
	"certificate" means a document issued by the Authority for a specified purpose;
	"certificate of origin" means a document issued by a competent authority from a country of origin confirming the origin of the nuts and oil crops produce or product;
	"collection centre" means a designated site that is established for the purposes of storage and marketing of different nuts and oil crops produce and products;
	"County Government" means the government provided for under Article 176 of the Constitution
	"dealer" means a person, company, co-operative society, association of

"dealer" means a person, company, co-operative society, association of persons or firm engaged in buying nuts and oil crops produce or byproducts for resale in the local or export market and includes exporter, importer, processor, ship chandler and agent;

"Directorate" means the Nuts and Oil Crops Directorate established under the Agriculture and Food Authority Act, 2013.

No.13 of 2013. "distributor" means a person that buys nuts and oil crops produce or products, warehouses them, and resells them to retailers or direct to the end users or customers.

"export" means to take nuts and oil crops produce and products to a place outside Kenya;

"grower" means a small or large scale nuts and oil crops farmer;

"inspector" means an officer of the Authority or a County agricultural officer appointed in writing by the Authority who derives power of entry from the Attorney General

"licensee" means a person who holds a licence granted under these regulations;

"import" means to bring into Kenya nuts and oil crops produce and products from another country;

"manufacture" means the processing of all nuts and oil crops produce and products and includes the packaging, labelling, distribution and importation of nuts and oils crops products for sale in Kenya;

"mother block" means selected plants established for the purpose of obtaining clean planting, grafting and budding material;

"mother plant" means a tree that has been identified and approved by the Authority as a source of planting, grafting or budding material;

"nursery" means a site approved by the Authority where seedlings are raised;

"package" means the container, receptacle or wrapper in which nuts and oil crops product is contained;

"person" includes an individual, company, firm, association or a corporation;

"raw cashew nut, , raw macadamia" means unprocessed produce still in shell;

"record" means a written or electronic data or information relating to a process or procedure;

"stakeholder" means any person involved directly or indirectly in the nuts and oil crops industry;

"rootstock" means the part of a plant which forms the root system of the plant, and into which a scion cultivar is grafted or budded;

"scion" means a detached shoot or bud used in vegetative propagation in the process of grafting or budding;

"ship chandler" means a person registered and authorized by the Authority to supply nuts and oil crops produce and products to a ship or an aircraft;

"small holder" means a person with less than ten acres under nuts or oil crop;

"plantation" means a person with ten acres or more under nuts or oil crop;

"traceability" means ability to track nuts and oil crops produce and products from production to the final consumer and vice versa;

"transporter" means a person who is engaged in transportation of nuts or oil crops produce and products;

"trader" means a person who transacts the business of nuts or oil crops produce or products;

"warehousing" means the process of storing nuts and oil crops produce and products from growers or dealers;

"warehouseman" means a company registered in Kenya and is in the business of storing nuts or oil crops produce and products from producers or dealers; and

"warehouse" means a building or premises intended for storage of nuts or oil crops produce and products.

Scope and Purpose of the **3.** The purpose of these Regulations is to provide guidelines to the nuts and oil crops industry and provide forregulations.

- (a) The application processing procedures and forms;
- (b) The conditions for registration and licencing of produce and product dealers and nursery operators;
- (c) The recommendation of general industry agreements or contracts between produce dealers and nuts and oil crops producers;
- (d) The compliance with quality and safety standards;
- (e) The harvesting, processing and marketing of nuts and oil crops;
- (f) The filing of statistical returns;
- (g) The imposition and administration of levies;
- (h) such other matters as may be deemed necessary for effecting these Regulations.

PART II: FUNCTIONS OF THE DIRECTORATE

Functions of the Directorate. 4. (1) The Directorate shall, in consultation with the county governments, perform the following functions—

- (a) administer the Crops Act, in accordance with the provisions of the said Act, as it relates to nuts and oil crops industry;
- (b) regulate the production, post-harvest handling and marketing of nuts and oil crops produce and its by-products;
- (c) provide advisory and regulatory services on matters related to the industry to the Authority and government for planning purposes;
- (d) collect, collate data and maintain a database on the industry;
- (e) promote the production, processing, grading, storage, collection, transportation and warehousing of all produce and by-products destined for markets;
- (f) recommend general industry agreements between grower associations and processors of scheduled crops;

- (g) appoint agents for the implementation or performance of any of the functions of the Directorate;
- (h) mediate and arbitrate disputes arising between growers and/or other players in the industry;
- (i) initiate, promote and enforce quality standards for products and by-products, during processing, labelling, grading, packaging, transport, and storage of produce and by-products.
- (2) In addition subsection (1), the Directorate shall—
 - (a) regulate imports and exports of the produce and by-products for the efficient management of the nuts and oil crops industry;
 - (b) enhance technical capacity for the county government officers and other relevant stakeholders and provide technical materials;
 - (c) be responsible for advising on research priorities in nuts and oil crops industry;
 - (d) vet contracts entered into between growers and other players or among other players in the industry before they are executed
 - (e) collect and administer nuts and oil crops levies to enhance development and research in the sub sector;
 - (f) coordinate matters of international protocols and conventions
 - (g) perform such other functions that may be assigned to it by the Cabinet Secretary or the Authority.

PART III—REGISTRATION OF NURSERY OPERATORS

5. (1) A person shall not establish or operate a nursery or a mother block in any area unless the person is trained and registered with the relevant County Government.

- (2) In addition, he shall be registered with other relevant government agencies such as Kenya Plant Health Inspectorate Services in accordance with these Regulations.
- Application for registration or6. (1) A person who intends to operate a nursery or mother block shall make application for registration to the relevant County Government as

renewal. set out in form A of the First Schedule. (2) The relevant County Government shall issue a certificate of registration to a successful applicant. (3) The certificate of registration of a nursery operator as set out in Form B in the First Schedule shall— (a) be renewable after one year; and (b) only applicable for a specified inspected area. (4) The operator of a nursery shall avail the certificate of registration for inspection when requested. Conditions for 7. A person shall not be issued with a certificate of registration for a granting nursery nursery, under regulation 6 unless a joint inspection team composed of certificate. (a) has visited and inspected the site and is satisfied that the site is suitable for establishment of a nursery; and (b) is satisfied that the nursery operator or the operator's agent has adequate knowledge of nursery management and production techniques. Revocation of 8. The relevant County Government may with the advise from the certificate Authority revoke a certificate of registration issued to a nursery or a registration. mother block operator if that operator fails to abide by the conditions set out in the certificate of registration. Statistical returns. 9. Every registered nursery operator shall, not later than the fifteenth day of the first month of every quarter of a financial year complete and submit to the relevant County Government and a copy to the Authority, statistical returns as set out in Form C of the First Schedule. Approved **10.** (1) Every person operating a nursery shall procure planting materials or planting material seeds from sources approved by the Authority. or seed source (2) In addition a nursery operator shall provide documentation upon request that the seeds or seedlings propagated are certified by a relevant Government Agency.

(3) A person who contravenes this regulation commits an offence.

Mother plants, mother block and nursery establishment. **11.** A mother plant, mother block or nursery shall be established in accordance with the procedures recommended by the Authority in consultation with relevant County Government.

Good agricultural practices. **12.** Every grower shall comply with the guidelines for product processing set out in the Fourth Schedule and good agricultural practices in—

- (a) production;
- (b) site selection;
- (c) spacing;
- (d) soil and water analysis;
- (e) records and document control;
- (f) traceability;
- (g) hygiene and cleanliness; and
- (h) workers' welfare among others.

PART IV— REGISTRATION AND LICENSING

- **13.** (1) A person who intends to bulk, trade, retail, transport, distribute or warehouse nuts and oil crops products shall make an application for registration to the relevant County Government as set out in form D1 of the First Schedule.
 - (2) The relevant County Government shall issue a certificate of registration to successful applicants under paragraph (1) set out in Form E1 of the First Schedule.

(3) The certificate of registration shall be valid until the thirtieth of June next following the date of issue, unless earlier cancelled

- 14. (1) All small-holder growers, for purposes of accessing economies of scale, shall have the freedom to register with an association registered by the relevant County Government under these Regulations.
 - (2) All Nuts and Oil Crops Associations, Common Interest Groups, Community Based Organizations and Co-operatives dealing with nuts and oil crops shall apply to the relevant County Government for a registration as set out in form D3 of the First Schedule.
 - (3) The relevant County Government shall issue a certificate of Registration to Associations, Common Interest Groups, Community Based Organizations and Cooperatives as set out in Form E2 of the First Schedule
 - (4) All Nuts and Oil crops plantation growers shall apply to the relevant County Government for a registration as set out in form D3 of the First Schedule
 - (5) The relevant County Government in consultation with the Authority shall issue a certificate of Registration to plantation growers as set out in Form E3 of the First Schedule
- Issue of License **15.** (1) A person who intends to process, import or export nuts and oil crops produce or products shall make an application for registration to the Authority for a licence as set out in form D2 of the First Schedule.
 - (2) The Authority shall issue a licence to successful applicants under paragraph (1) set out in Form E4 of the First Schedule
 - (3) The licence issued under this regulation shall remain in force until the thirtieth of June next following the date of issue, unless earlier cancelled.
 - (4) The Authority shall, at least thirty days before granting a licence under these Regulations, give notice of the proposed grant in the Gazette and in such other manner as the Authority may determine.
- Tree felling 16. (1) A person who intends to cut wood from nuts and oil tree crops shall make an application for a permit to the relevant County Government as set out in form D4 A of the First Schedule.
 - (2) The relevant County Government shall issue a permit for the cutting of wood from nuts and oil tree crops as set out in Form E5 of the First Schedule.

(3) The permit issued under this regulation shall expire at the specified dates indicated on the permit.

Permits for transportation of wood and raw nuts and oil crops produce

- **17.** (1) No person shall move or cause to be moved, any wood from nuts and oils tree crops; or any raw nuts and oil crops produce without an original movement permit issued by the relevant County Government.
 - (2) A person who intends to transport wood from nuts and oil crops trees or raw nuts and oil crops produce shall make an application for a permit to the relevant County Government as set out in form D4 B of the First Schedule.
 - (3) The relevant County Government shall issue a permit for the movement of wood from nuts and oil crops trees or raw nuts and oil crops produce as set out in Form E6 of the First Schedule.
 - (4) Movement permit for wood from nuts and oil crops trees or raw nuts and oil crops produce shall be issued only once and at the County of origin
 - (5) A person who contravenes any of the provisions of this regulation commits an offence.

18. (1) Every local trader, local processor, retailer, transporter, distributor and marketing agent of nuts and oil crops produce and products shall, not later than the tenth day of every month, complete and submit to the relevant County Government and copy to the Authority statistical returns in accordance with the provision of section 40 (2) (m) of the Crops Act and as set out in Form F of the First Schedule.

(2) Every large scale processor, importer, and exporter of nuts and oil crops produce and products shall, not later than the tenth day of every month, complete and submit to the Authority statistical returns in accordance with the provision of section 40 (2) (m) of the Crops Act and as set out in Form F of the First Schedule

Renewal of **19.** (1) Every annual registration granted under these Regulations shall expire on 30th of June following the date of issue unless earlier cancelled

> (2) Applications for renewal shall be made within three months before expiry but not later than one month before expiry of such renewal.

> (3) Late application shall attract a penalty of fifty per centum of the certificate or licence fee.

Dealer's annual **20.** (1) Every local trader, local processor, retailer, transporter, distributor renewal fee. and marketing agent shall pay a dealer's annual renewal fee as set out in the Second Schedule.

> (2) Every large scale processor, importer, and exporter shall pay a dealer's annual renewal fee as set out in the Second Schedule.

21. (1) The relevant County Government or Authority shall revoke the certificate of registration or licence of a specific dealer if the certificate or license holder fails to abide with the provisions of these Regulations and any other written law.

- (2) Before a certificate of registration or license is revoked under subregulation (1), the certificate or license holder shall be given—
 - (a) sufficient notice of the intention to revoke the certificate or license: and
 - (b) an opportunity to present their case.
- (3) The notification referred to in sub-regulation (2) shall be sent to the certificate or license holder by registered post.
- (4) Where a certificate of registration or license is revoked under these Regulations, the holder shall not be entitled to any claim from the relevant County Government or Authority or the National Government for any compensation or any damages occurring from such revocation.
- **22.** (1) The relevant County Government or Authority, in considering an application for any registration, licensing or, renewal under these Regulations, shall make a decision within thirty days after receipt of an application for registration or its renewal.
 - (2) Where an application for a renewal of registration or license is made, the registration certificate or license shall be deemed to continue in force until the application for renewal is determined and communicated to the applicant.
- 23. The relevant County Government or Authority may require an applicant information. for registration, licensing or renewal specified under these Regulations to supply such additional information as it considers necessary in relation to the application.

Imposition of 24. The Authority, in consultation with the Cabinet Secretary or the relevant further terms.

conditions and restrictions. County Government may, at any time, by written notice to dealers vary any terms, conditions, restrictions; or impose further terms, conditions or restrictions.

- Certificate of registration not transferable. **25.** A certificate of registration, license or permit issued under these Regulations shall not be transferrable to another entity and shall be applicable only to a farm or premise which has been inspected.
- Compliance with quality standards. **26.** All nuts and oil crops produce or products offered for sale shall, where applicable, comply with relevant
 - (a) National, regional and international standards;
 - (b) food safety and hygiene requirements; and
 - (c) sanitary and phytosanitary requirements.

Exports compliance with applicable laws and regulations.

Imports compliance with the standards.

- **27.**(1) Every exporter shall comply with the relevant laws and regulations of export of the Nuts and Oil crops products.
- (2) Every exporter shall, not later than the tenth day of every first month of the quarter of the year, complete and submit to the Authority statistical returns in accordance with the provision of section 40(2) (m) of the Crops Act and as set out in Form F of the First Schedule.
- **28.** (1) A person importing nuts and oil crops produce or product into Kenya shall, where applicable, first clear with the following government agencies before being cleared by the Authority—
 - (a) Kenya Bureau of Standards;
 - (b) Kenya Plant Health Inspectorate Services; and
 - (c) any other relevant government agency.
- (2) Every importer shall, not later than the tenth day of first month of the quarter of the year, complete and submit to the Authority statistical returns in accordance with the provision of Section 40(2) (m) of the Crops Act and as set out in Form F of the First Schedule.
- (3) A person who imports material contrary to these Regulations commits an offence and is liable on conviction to a fine two times the value of the material or imprisonment for a term not exceeding one year or both.
- (4) In addition to the penalty in sub regulation (3), the person may, have

their licence revoked.

29. (1) A registered dealer shall—

Contracts between two parties.

- (a) sign a contract with the producer and register such contract with the relevant County Government and the Authority as set in the Third Schedule;
- (b) indicate the contract price, quantity, quality requirements, the maximum payment period and delivery date;
- (c) notify the ±¤≪µ 3 #[®] 3, '[®]µ¤±-¬ ¤-3 £ 3S¤ ! ´ 3S[®]±"3</sup>, of any dealer or producer who contravenes any contract or order within thirty days after the date of the default;
- (d) Any person who contravenes the provisions of these Regulations commits an offence and is liable, on conviction to the penalties prescribed under the Crops Act 2013.
- (2) The relevant County Government and the Authority shall set up a seven (7) member committee composed of the Authority, Relevant County Government, three (3) farmers, one (1) processor and one (1) trader to mediate and arbitrate disputes arising between growers and other players in the industry.

Compliance with contracts between two parties.

- **30.** (1) A registered dealer shall not—
 - (a) sponsor growing of nuts and oil crops for trading without informing the relevant County Government in writing, and any production scheme so sponsored shall be regulated by a contract as set out in the Third Schedule;
 - (b) collect produce and products from sponsored production schemes unless authorized to do so by the sponsoring firm; or
 - (c) return produce and product collected from the producer or supplier, contrary to the contract agreement
- (2) A registered dealer shall pay for collected produce within the time stipulated on the contract agreement, failure to which he shall be required to pay the full amount of the produce plus interest accrued as per existing commercial rate
- (3) A registered dealer shall be required to have in his possession, a copy of the contract which he shall produce upon demand by a person duly authorized in writing by the Authority or relevant County Government.

Traceability of produce and products. **31.** Every producer and dealer shall develop, implement and monitor a precise and detailed traceability system to ensure that consumers are informed correctly on the nuts and oil crops produce and products.

32. (1) Traceability records relating to the produce and products shall be kept and maintained by growers, manufacturers and dealers for at least two years.

(2) Traceability records relating to the seed and seedlings of nuts and oil crops shall be kept and maintained by growers and nursery operators for at least five years.

Contravention of this Part
 (3) A person who contravenes the provisions of these Regulations commits an offence and is liable, on conviction, to the penalties prescribed under the Crops Act 2013.

PART V—HARVESTING, PROCESSING AND MARKETING PROVISIONS

- **33.** (1) Harvesting of nuts and oil crops shall be done when the produce is physiologically mature for the intended use and during the harvesting seasons that shall be designated by the relevant County Government from time to time.
 - (2) Nuts and Oil Crops produce and products shall be harvested, sorted, graded, packaged, transported and stored in accordance with the guidelines set out in the Fourth Schedule and the specific National or International nuts and oil crops produce standards
 - (3) A person who deals with the processing and selling of nuts and oil produce and products shall, not later than the tenth day of the first month of the quarter of the year, complete and submit to the Authority and copy to the relevant County Government statistical returns as set out in Form F of the First Schedule.
 - (4) All premises for storage and processing of Nuts and Oil crops produce and products shall be built and maintained in accordance with the hygienic conditions stipulated in the Public Health Act and should ensure conformity to food safety and quality standards in accordance to national and International regulations
 - (5) Any person who contravenes these regulations shall be guilty of an offence and liable to the penalties prescribed under section 37 of the Crops Act 2013.

Marketing **34.** (1) The growers shall market their produce through collection centres. through collection The collection centres shall be used as centres. (a) sites for grading and bulking of nuts and oil crops produce and products to achieve marketable volumes; (b) collective bargaining and negotiations and signing of contractual agreements between producing clusters and traders; (c) points for lodging and arbitration of disputes between aggrieved parties; (d) centres of information dissemination on prices, markets and other technologies on nuts and oil crops industry improvement; and (e) collective acquisition and distribution of agricultural inputs, provision of advisory services, credit and other agricultural services (2) The Authority in consultation with the relevant County Government shall, from time to time issue guidelines on the establishment and management of nuts and oil crops produce and products collection centres. Inspectors. 35. (1) There shall be Inspectors who shall be appointed and their names published in the Kenya Gazette by the Authority in accordance with section 27 of the Crops Act 2013. (2) A person appointed as an inspector under sub regulation (1) shall-(a) be persons that hold a minimum of a degree in agriculture or related field from a recognized Institution; and (b) have the relevant expertise and experience in agriculture. (3) A person appointed as an inspector shall declare interest and step aside for inspection to be done in business where he has interest. (4) In the exercise of their powers of entry and inspection, the inspectors

(5) Without prejudice to the generality of regulation 23, inspectors shall monitor activities associated with nuts and oil crops produce and

- (a) inputs, production, dealing, and processing to ensure compliance with these regulations;
- (b) regularly undertake surveillance and inspections to ensure that-
 - (i) production, distribution and use of inputs for food crop production conform to provisions of these regulations;
 - (ii) growers of nuts and oil crops produce and products apply good agricultural practices to ensure quality and safety of the produce;
 - (iii) dealers and processors in nuts and oil crops produce and products adhere to the terms and conditions of registration, licensing and guidelines set out in schedule 4.
- (6) The inspectors shall work in collaboration with the County Executive Committee member in charge of Agriculture in discharge of their functions.
- Inspector's entry.
 36. (1) An inspector shall, upon availing an identification from the Authority, be allowed at all reasonable times to access any farm, land or premises on which nuts and oil crops produce or products are grown, stored, warehoused, processed or reasonably suspected to be grown, stored, warehoused or processed.
 - (2) An inspector shall upon entry on a farm, land or premises ascertain whether the provisions of the Crops Act 2013 and these regulations are being complied with.
 - (3) Where an inspector has reasonable grounds to suspect that any provision of the Crops Act 2013 or these regulations is being flouted, the inspector may require the owner, occupier or agent present to furnish any required information or material relating to the matter under inspection.
 - (4) Any person who prevents, hinders or obstructs an inspector in performance of their functions and duties commits an offence
 - (5) A person convicted of an offence under these regulations is liable to

the penalties prescribed under the Crops Act 2013.

(6) In addition to the penalty referred to in sub-regulation (5) a convicted person shall, where applicable, have their registration certificate revoked.

PART VI—FINANCIAL PROVISIONS

37.(1) The Cabinet Secretary with the approval of Parliament, hereby imposes a levy to be levied on all nuts and oil crops produce and products at the point of import or export as set out in the Second Schedule of these regulations and in accordance with section 32 of the Crops Act 2013.

- (2) Different rates of levy may be imposed for different types of nuts and oil produce and products.
- **38.** (1) A person who fails to pay the amount due in respect of any levy imposed under these Regulations commits an offence.
 - (2) Any levy which remains unpaid shall be recovered by the Authority as a civil debt due to it from the person by whom it is payable.
 - (3) Any levy that remains unpaid for a period of thirty days or more shall attract interest at commercial bank rates until it is fully paid.
 - (4) Import and export levy on nuts and oil crops produce and products shall be charged as follows—
 - (a) four percent of cost insurance and freight of imported finished products;
 - (b) two percent of cost insurance and freight of imported raw material;
 - (c) Kenya shillings two per kilogram of freight on board value of exported raw produce except those prohibited from export under section 43 of the Agriculture and Food Authority Act 2013; and
 - (d) zero point two five percent of freight on board value of exported finished product
 - (5) An exporter of nuts and oil crops produce and products shall register

General power to impose a levy on nuts and oil crops produce and products.

Offence.

the exports made and make a return of all transactions to the Authority in Form F set out in the First Schedule.

- (6) Any importer or exporter who provides false information required under these regulations shall be guilty of an offence and liable to the penalties prescribed under section 37 of the Crops Act 2013.
- (7) All exporters and importers shall provide documentary evidence to the Authority or its collection agents of having paid the applicable levy
- (8) The Authority or its authorized agent shall have the power to verify customs documentation on exports and imports of any nuts and oil crops produce and products consignments and issue an import or export release order in the manner prescribed in Form G under the First Schedule.
- (9) The Authority shall not issue a release order if an exporter or importer is in contravention of the provisions of the Crops Act or any regulations made there under.
- (10) The Authority may cancel the export or import release order if an exporter or importer contravenes the provisions of the crops act or any regulations made thereunder
- (11) An importer of nuts and oil crops produce and products shall register the imports made and make a return of all transactions to the Authority in Form F set out in the First Schedule.
- **39** (1) A nuts and oil crop tree shall not be cut except in the following instances and only after an inspection has been carried out and a permit issued by relevant County Government—
 - (a) where the tree is no longer economically productive;
 - (b) where the tree is disease-infested;
 - (c) where the tree is damaged by natural calamities;
 - (d) when the agricultural land devoted to production is to be converted, according to the law, into residential, commercial or industrial use;
 - (e) when the land devoted to production is to be converted into other

agricultural uses or other agriculture-related activities in pursuance to conversion duly applied for by the owner and approved by the proper authorities; or

- (f) where the tree would cause hazard to life or property.
- (2) Despite sub-regulation (1), no conversion shall be allowed by the relevant County Government until after it has been certified that for a period of at least three years the—
 - (a) majority of nut and oil crop trees have become senile and economically unproductive; and
 - (b) nut and oil crops farm is not adaptable to sound management practices on account of—
 - (i) the geographical location;
 - (ii) topography;
 - (iii) drainage; and any other condition rendering the farm economically unproductive.
- (3) A permit to cut a tree or plant shall not be granted unless the applicant, in consultation with relevant County Government agricultural officer, has planted three seedlings to replace the tree or plant cut.
- (4) Despite sub regulation (4), the replanting shall not apply to areas converted into industrial, commercial or residential sites or land transformed in accordance with the law into other agricultural purposes.
- (5) The relevant County Government shall confirm whether replanting was done and oversee the planting, fertilization and care of the newly planted nuts and oil crop trees.
- (6) In the implementation of sub regulation (5), the relevant County Government agricultural officers shall conduct, from time to time, on-the-spot inspections of the sites where nuts and oil crop trees have been replanted.
- (7) A person convicted of an offence under this regulation is liable to the penalties prescribed under section 37 of the Crops Act 2013.

PART VII-MISCELLANEOUS PROVISIONS

- Protection from personal liability.40. An action shall not lie against the Authority, Directorate or relevant County Government or any of its officers or other persons appointed or authorized to perform any function under these Regulations in respect of anything done or omitted to be done by them in good faith in the exercise of or performance of any power, authority or duty conferred or imposed by them under these Regulations.
- General penalty.41. A person who contravenes any provision of these Regulations for which no specific penalty is prescribed, commits an offence and is liable, on conviction, to the penalties prescribed under section 37 of the Crops Act 2013.
- Repeal. **42.** Legal Notice No 165 of 2007 which established Kenya Coconut Development Authority is revoked.





(Regulation 33 (2))

PART A

MINIMUM REQUIREMENTS FOR FIELD HANDLING AND GRADING OF NUTS AND OIL CROPS PRODUCE

- 1. High standards of field hygiene shall be maintained during harvesting operations.
- 2. All harvested produce SHALL be at the right stage of maturity for intended use.
- 3. Harvested produce shall be protected from adverse weather conditions
- 4. Appropriate harvesting equipment shall be used for each crop.
- 5. Produce unfit for marketing shall be separated from marketable produce at the field level.
- 6. All produce shall be sorted and graded as appropriate.
- 7. Physical handling of produce shall be minimized at all stages.
- 8. All harvested produce shall be bulked at the growers collection centres before being sold to traders
- 9. The collection centre shall—
 - (a) be accessible to both buyers and farmers;
 - (b) be designed to allow for a store, an office, working area and an appropriate cooling facility where applicable;
 - (c) have floors, doors, wall surfaces made of impervious, non-toxic, washable materials, which are easy to clean and disinfect;
 - (d) be constructed to allow for adequate ventilation, lighting, effective produce inspection and made of acceptable materials
 - (e) adequate water and toilet facilities;
 - (f) have waste disposal facilities; and
 - (g) have clear documentation procedures and document control systems.



AGRICULTURE AND FOOD AUTHORITY (Nuts and Oil Crops Directorate)

PART B

MINIMUM CONDITIONS APPLICABLE TO PROCESSING FACILITY

- 1. All processing and packaging must be carried out in a clean, hygienic and safe conditions as set out under the provisions of the Public Health Act, Cap. 242 and the Occupational Safety and Health Act, No. 15 of 2007.
- 2. The working areas and premises shall be kept free of waste materials.
- 3. Any person in the processing facility shall wear protective clothing at all times
- 4. All hand used equipment and grading tables shall be rust proof and easily cleaned.
- 5. The floor layout shall allow for smooth flow of produce with adequate separation of raw materials and finished products
- 6. The floors, doors and wall surfaces shall be made of impervious, non- absorbent, non-toxic washable materials which are easy to clean and disinfect.
- 7. The processing facility shall have adequate ventilation, temperature control and lighting.
- 8. All machinery used in the processing facility shall conform to the provisions of <u>the</u> <u>Public Health Act</u>, Cap. 242 and Occupational Safety and Health Act, No. 15 of 2007.
- 9. The processing facility shall be designed and constructed to prevent entry of domestic animals, rodents, insects, birds, dust and any other unwanted animals.
- 10. Prominent signs shall be displayed forbidding smoking, eating or drinking within the facility.
- 11. All packaging materials shall be kept off the floor in clean dry storage areas free from risk of contamination.
- 12. The traceability of all produce shall be documented throughout the process chain.



AGRICULTURE AND FOOD AUTHORITY (Nuts and Oil Crops Directorate)

PART C

MINIMUM REQUIREMENTS FOR PACKAGING, TRANSPORTATION AND STORAGE

- 1. The packaging shall protect the produce and products from mechanical and physiological damages to minimize loss of quality.
- 2. The packaging shall be designed to suit the transport handling system and have capacity to meet market requirements.
- 3. The packaging material used shall be able to contain the produce and products, enabling the required quantity to be handled as one unit.
- 4. Nuts and Oil crop produce and products shall during storage and transport be kept at the prescribed temperature and humidity levels for each produce and product.
- 5. Nuts and Oil Crop produce and products shall not be stored or transported together with other produce and products, which may contaminate them or otherwise adversely affect their quality.
- 6. Vehicles for transport shall be built and equipped to ensure maintenance of optimal temperatures to prevent damage and spoilage of produce and products.
- 7. Persons handling the produce and products must be healthy, protected and trained on produce and product handling.
